\$3 Virtual Rewards Card or \$3 PayPal with receipt submission showing purchase of \$9 of participating Rayovac® Products

How to Participate: Purchase \$9 of participating Rayovac® brand products identified below (“**Rayovac® Products**”) in a single transaction between 11/1/17 and 1/31/18 at a retailer selling Rayovac® Products (hereafter, “**Eligible Purchase**”) and you will be eligible to receive a choice of either a \$3 Virtual Rewards Card or \$3 PayPal (hereafter, “**\$3 Reward**”) (subject to compliance with these Official Terms & Conditions).
